## Tablet Program Parent Agreement Form

Technology in the Worthington School District has been integrated to help prepare students in a rapidly changing world. Students' proper use of technology is a valued resource to our community. All electronic technologies must be used to support the educational programs in the District. Access to the District's technology may be revoked at any time for abusive or inappropriate conduct related to the use of digital technologies.



Failure to comply with the District's Internet Use and Safety, and Electronic Communications Policy (524), Bullying Prohibition Policy (514), or the guidelines stated in the Tablet Implementation Guide may result in the loss or privilege to take the tablet home or use of the device in general. <http://goo.gl/4SzB70>

The devices are the property of Worthington Public Schools and as a result may be seized and reviewed at any time. The student should have NO expectation of privacy of materials found on a school owned device.

Individual school devices, cases, and accessories must be returned following ISD518's procedure at the end of the school year. Students who graduate early, withdraw, are expelled, or terminate enrollment at ISD518 for any other reason must return their individual school device and accessories on the date of termination. In the case of suspension, you will turn in your device and accessories to a building Administrator on the date of suspension.

If a student fails to return the device at the end of the school year or upon termination of enrollment in ISD518, that student will be subject to criminal prosecution or civil liability. The student will be required to pay the replacement cost of the device. Failure to return the device will result in a theft report being filed with the Police Department.

### Optional Tablet Insurance

Insurance is available for all District issued devices. *Families who purchase insurance after receiving a device, either an iPad or a Dell, must have the device inspected by tech staff in order to verify the device is not damaged at the time of insurance purchase.* Insurance will cover the school year, from date of inspection after purchase until the end of the school year. The annual cost of the insurance is \$20 per device per year. Students will not be allowed to take devices home during summer school.
